# Global InterAction vuTools Source Code License

This vuTools source code license agreement ("Agreement") is a legal agreement between you (either as an individual or as an organization such as a company) and Global InterAction ("GI"). The agreement covers the use of source code, related information and documentation, for the specific version of the vuTools source code which you have purchased (together the "Source Code"). By viewing or using the Source Code, you agree to be bound by the terms of this Agreement. If you do not agree to the terms of this Agreement, GI will not license the use of the Source Code to you. If you do not agree to the terms of this Agreement, you must not view or use the Source Code, and you must destroy any copies of the Source Code in your possession.

This Agreement supersedes and replaces all previous licenses in respect of the Source Code. and constitutes the entire agreement between the parties with respect to its subject matter, and supersedes all prior agreements, understandings, proposals, representations and discussions between the parties, whether oral or written. There are no understandings, agreements, representations or warranties, expressed or implied not expressly specified herein.

This Agreement cannot be changed except by written agreement between the parties.

## Grant of license

GI grants you the non-exclusive, limited right to (i) use and modify one or more copies of the Source Code for the purposes of developing, designing and testing one or more software products ("Application") (ii) redistribute to your own company end users (including employees, business partners and suppliers) your modified version of the Source Code in compiled form as part of your Application (iii) make one or more back-up copies of the Source Code and use them solely for back-up and archival purposes, provided you comply with the following terms:

- you agree to indemnify and hold GI harmless from and against any and all damages, losses, costs, claims, expenditure and liability arising out of or related to the use or distribution of your Application; and
- you must include a copyright notice in your Application of equal prominence as any other copyright notice as follows: "This product includes software licensed from Global InterAction and its licensors (c) Global InterAction and its licensors 1994-2005"; and
- 3. you may not transfer any of your rights or obligations under this Agreement to any other person or company; and
- 4. you may not sell your Application to any other person or company (except to companies which are directly controlled by your company or your parent company if one exists); and
- you must not use GI's trade marks, name or logos on or in relation to your Application or otherwise to market your Application without GI's explicit approval, and you must not make representations that your Application is in any way endorsed by or connected with GI without GI's explicit approval; and
- 6. you agree to inform any recipient of your Application that no intellectual property rights in the Source Code are transferred to that recipient

## Termination

This Agreement lasts until you terminate it by destroying all copies of the Source Code. If you fail to comply with the terms and conditions of the Agreement, then GI may terminate this Agreement and you will then be required to destroy all copies of the Source Code.

### **Intellectual Property Rights**

The Source Code is protected by international copyright laws and treaty provisions, as well as other intellectual property laws and treaties. The Source Code is licensed, not sold.

All title, copyright, and all other intellectual property rights in and to the Source Code are owned by GI and GI's licensors. Except as specifically set out in this Agreement you may not copy, sell, distribute, offer for sale or in any way disclose to third parties the Source Code. All rights not specifically granted under this Agreement are reserved by GI. GI reserves its rights separately to license these rights to any recipient of your Application.

#### No warranty

Except where otherwise stated in writing, GI provides the Source Code "as is" without warranty of any kind. The terms of this license set out the full extent of GI's liability in respect of the Source Code. The Source Code is licensed to you for the designated purchase price. You accept that there is no representation, warranty, condition or term as to the performance or quality of the Source Code and that no such representation has been made to you. Should the Source Code prove defective, you are solely responsible for the cost of all servicing, repair or correction of the Source Code and of any Application. You shall have no remedy in respect of any untrue statement made to you upon which you relied in entering into this Agreement (unless that statement was made knowing that it was untrue) other than any remedy you may have for breach of the express terms of this Agreement. Any condition, warranty, representation or other term relating to the supply or failure to supply the Source Code which would otherwise be implied into or incorporated into this license (including, without limitation, the implied terms of merchantability, satisfactory quality and fitness for purpose), whether by statute, common law, course of dealing, contract or otherwise, is hereby excluded to the extent permitted by law. In any event, GI's liability arising out of or in connection with this Agreement or any collateral contract, whether in contract, tort or otherwise, shall not in any circumstances exceed \$100. GI shall not be liable in any way for any loss of revenues, profits, business or anticipated savings or, without limitation, for any indirect or consequential loss or damage suffered by you or any third party in connection with this Agreement notwithstanding that GI may have been notified of the possibility of such damage. Nothing in this Agreement shall exclude or limit GI's liability for the tort of deceit or for death or personal injury caused by its negligence. Nothing in this Agreement will affect the statutory rights of any consumer.

### **General Provisions**

This Agreement is governed by the laws of the United States of America, and if any disputes arise from or in relation to it, you agree to submit to the exclusive jurisdiction of the United States of America Courts, save that GI may institute proceedings against you in any competent jurisdiction.
